

Knowledge Management

The CARIS programme, providing a physical and virtual resource centre, continued to ensure that faith leaders, activists, and implementers worldwide has access to accurate and reliable information on all aspects of HIV.

Website and Social Media Presence:

The CARIS Programme was not only responsible for the websites and social media of CABSA but also provided support for the Thursdays in Black campaign and for We Will Speak Out SA, a coalition of faith communities responding to sexual and gender-based violence.

The www.cabsa.org.za website continues to grow and consists of more than 8130 pages of news and resources on every aspect of HIV and a sermon database with 711 sermon guidelines. The redeveloped www.thursdaysinblack.co.za website has a large collection of resources on various gender and gender-based violence areas, including faith-based materials. CABSA also coordinated the WWSOSA website and planned the new independent page that will be launched in 2018.

Material Distribution

More than 18 000 free resources, including books, pamphlets and DVDs, were distributed.

A Year of Impact and Momentous Decisions



When reviewing 2017, it is again amazing to think of all the lives that were impacted by the activities of CABSA. I think of the lives changed through four Churches Channels of Hope facilitator trainings, peer educator trainings, the CHABAHIVA funded peer educators programme in two districts in the Western Cape and a church competence programme in Mamelodi.

I think of the insights from activities and consultations in the Paediatric HIV Advocacy Campaign and from the weekly Bible Message.

I think of the many thousands of people who joined the Thursdays in Black campaign, including in a very large roll-out in the Rhema Church family and in churches world-wide.

I think of the excitement of survivors of gender-based violence who were equipped to become involved in advocacy through the "Transformative Justice" workshops.

The list goes on and on. As always, the words in this report are far too few to tell all the stories and report on all

As always, I am amazed by the grace of God.

However, 2017 was also a year of particular challenges.

When writing this report a year ago, I wrote "where the epidemic is seen to be on a knife-edge, international roleplayers increasingly emphasise the value of faith communities and faith responses in the epidemic. Sadly however, very few faith-based initiatives focussing specifically on HIV remain."

In 2017 this challenging context came much closer to CABSA and very difficult decisions had to be made. As described elsewhere, this is my last report in my capacity as CABSA Executive Director. I recently read a quote from Mark Rowlands wishing "that you find something in your life so important that without

it you would not be the same person." Without any doubt I look back on my 14 years with CABSA with immense gratitude, knowing that my life was enriched and deepened by interactions with many thousands of individuals and organisations. It is impossible to

describe in how many ways my life has changed, or to even begin mentioning all the people who played a role in

Churches Channels of Hope

The Churches, Channels of Hope (CCoH) programme continues to assist participants to recognize and hear God's voice in the HIV

In 2017 CABSA witnessed yet again how God used the different trainings and workshops to transform lives and equip individuals to also make a difference. The following quotes highlight the experiences of participants:

- How the Bible and HIV connect has really brought an AWE moment on how to give hope to people either infected or affected without judaina.
- I had no believe(sic) in the things that were quote(d) from the Bible mainly because people interpreted (it) in a way that is complicated, but now I do understand the need of it.
- I feel more equipped for having a conversation on Christianity and HIV.
- Gave me courage to stand in front of people and go out of my comfort zone.

The CCoH Facilitator Training aims to empower faith leaders with healthy attitudes, thorough knowledge and skills to assist faith communities in their journeys to understand the epidemic and to respond to it. CABSA presented this training 4 times in 2017, to a total of 84 facilitators. Two of these trainings were on request of the Field Band Foundation.



The CCoH Peer Educator Training aims to empower ordinary people and community leaders to understand their own role as peer educators that can influence, inform and support people around them

The peer educator training was presented 3 times to a total of 30 people and one refresher training was presented to 14 peer educators.

Other highlights include that CABSA:

- Expanded the HIV Farm programme to De Doorns in the Western Cape. - Presented two Family Health Days, one in Wellington and one in De Doorns. A total of 500 adults and children attended these events and 160 participated in HIV testing and other health screening
- Partnered with the CHABAHIVA Trust to build more capacity for the Peer Educator training and entered into a license agreement, allowing the Trust to also use this

Governance and Staff

From a staff and governance perspective, 2017 was a tumultuous year.

The Annual General meeting (17 May 2017) accepted the new constitution with a refinement of vision and mission. In alignment with the changes, the Management Committee was disbanded and Ms Zani Malan was elected to the CABSA Board.

As the Board decided at the strategic meeting of 2016, a new staff member was recruited for Finances and Fundraising, in order to address the increasing pressure on finances. However, the appointment was unsuccessful and the employee's service was terminated during his probation period. Sadly, this ended in a CCMA case in which the commissioner found that CABSA acted procedurally and substantially fair. This increased the stress on the CABSA management and staff. In spite of this, a new financial system had to be developed and was implemented.

It became increasingly clear that 'business as usual' was not an option, and management and the Board entered into an intensive strategic planning process. The outcome of this process was that a number of scenarios were presented to the Board.

At a Board meeting in November, the Board made the difficult decision to refocus and restructure the organisation. CABSA will continue in 2018 with a focus on training and the Churches, Channels of Hope programme from the Wellington office. Sadly, this means that the CARIS programme and the Randburg office will be closed and staff reduced.

The Board believes that this decision was essential for the sustainability of the organisation. In spite of these dramatic changes, CABSA will continue to live out its mission to motivate and assist the Church to bring transformation in

the areas of health, well-being and gender equality in a world affected by HIV.


A Note from the Chairperson

Networking, Advocacy and Systems Strengthening

CABSA staff:

- are regularly involved in providing mentoring and advice to other non-profit organisations and supported various

Thursdays in Black (TiB): Participated in and presented at various gender conferences & events in FBOs, schools, churches and even commercial organisations; provided resources, participated and exhibited at the launch of TiB at the Rhema Church network; managed the TiB website, social media and distribution of campaign materials and resources.

We Will Speak Out SA: Management Committee member; provided social media, website and communication support; presented Transformative Justice Workshops; participated in AGM and 'Multilogue'; and was part of WWSOSA GBV Video.

World Council of Churches Ecumenical Advocacy Alliance: Member of the International Reference Group and HIV Strategy Group; coauthored letter with recommendations to the General Secretary of WCC; represented EAA and CABSA at the Ecumenical Strategic Forum on Diakonia and Sustainable Development; presented various information sessions and two successful dialogues between church leaders and adolescents as part of the Paediatric Advocacy Campaign; and co-hosted the faith networking site at ICASA 2017 in Cote d'Ivoire.
